- 5.e-tender system should be followed.
- 6. Store Purchase Rules should be strictly followed.
- 7. For construction work, Time of completion should be specified.

- 8.If accredited agency is executing the works, time of completion along with "penalty clause" should be include in MoU/Agreement.
- 9. For PWD works, PRICE software should be obtained.

The expenditure shall be limited to the budget provision and the same shall be met from the Head of Account concerned and the amount shall not be used for any other purpose.

The Director ,IHRD shall implement the scheme strictly in accordance with the plan write-up observing all the relevant rules.
