#### **ORDER**

As per the Government Order read as 1<sup>st</sup> paper above, Government have issued orders to release an amount of Rs.58.64 Lakh (Rupees Fifty Eight Lakh and Sixty Four Thousand Only) to IHRD for the NABARD - RIDF Project XVIII:(R182800119) Construction of Building for College of Engineering, Karunagappally against the reimbursement claim by debiting to the head of account '2203-00-112-55-35(PV)'. Unfortunately while submitting the bill at treasury, the amount could not be encashed due to some technical reasons.

Later as per Government Order read as 2<sup>nd</sup> paper above, sanction was again accorded to release the amount. But the same could not be encashed either due to lack of sufficient fund in the head of account. As per the Government Order read as 3<sup>rd</sup> paper above, the Finance Department has additionally authorized an amount of **Rs. 14.14 Lakh**(Rupees Fourteen Lakh and Fourteen Thousand only) under the head of account wherein a balance amount of **Rs.44.50 Lakh**(Rupees Forty Four Lakh and Fifty Thousand only) has already been available.

In the above circumstances Government are pleased to release an amount of **Rs.58.64 Lakh** (Rupees Fifty Eight Lakh and Sixty Four Thousand Only) to IHRD in respect of the work **NABARD - RIDF Project**
