As per the Budget Estimate 2019-20, an amount of Rs. 16,46,32,000/- (Rupees Sixteen Crore Forty Six Lakh Thirty Two Thousand Only) and Rs. 6,38,44,000/- (Rupees Six Crore Thirty Eight Lakh Forty Four Thousand Only) had been allocated to IHRD as Grant-in-aid - General Salary(NP) and Grant - in - aid General Non Salary (NP) under the head of account 2203-00-112-60-31 & 2203-00-112-60-36 respectively.

As per the Government Orders read above, Government have released the Grant - in - aid to IHRD timely as per the request of the Director, IHRD.

requested Government to release the balance amount of Grant - in - aid.

Government have examined the matter in detail and are pleased to release an amount of **Rs.2,89,32,000/-** (Two Crore Eighty Nine Lakh and Thirty Two Thousand only) from the H/A 2203-00-112-60-31 - General- Salary(NP) and **Rs. 4,34,13,920/-** (Four Crore Thirty Four Lakh Thirteen Thousand Nine Hundred and Twenty only) from the H/A 2203-00-112-60-36 - General- Non Salary(NP) to IHRD as the balance amount of Grant - in - aid.


