- 5 .Stores Purchase rules should be strictly followed.
- 6. For construction work, time of completion should be specified.
- 7 .If accredited agency is executing the work, time of completion along with the "penalty clause' should be included in MoU/Agreement.
- 8 . For PWD works, PRICE software should be obtained.
