ORDER

As per the Government Order read as 1st paper above, Government have released an amount of **Rs. 125.34 Lakh** (Rupees One Crore Twenty Five Lakh and Thirty Four Thousand Only) to IHRD for the NABARD - RIDF Project : (R 182800122) for the construction of building for College of Engineering, Poonjar against the reimbursement claim by debiting the Head of Account ' **2203-00-112-55**.

When the bill was submitted to treasury for releasing the amount, it is informed from the treasury that no sufficient fund was deposited in the particular head of account .

IHRD - RIDF XVIII of NABARD - 35(PV)' .This additional expenditure has been authorised vide Government Order read as 2nd paper above.


